The Palliative Care Nurse assesses patients and families, and provides care as per knowledge, skill and ability within the professional scope, conduct and demeanor of practice of a Registered Nurse and the standards of care as approved by the College of Nurses of Ontario, while ensuring that the CNO Ethical Guidelines for Behaviour and CNA Code of Ethics is adhered to. Participates with other health professionals in providing care and counselling for palliative care and oncology patients. In addition, provides training/education and facilitation for patients, families and the community. The Oncology/Palliative Care Nurse has the ability to work flexible hours.
